Mr. Josh Kerbel

Mr. Josh Kerbel is a Professor of Practice at NIU, where he researches the increasingly complex security environment and the associated intelligence challenges. More specifically, he explores anticipatory intelligence: how the IC can better anticipate the appearance and/or course of emergent security phenomena. Prior to joining NIU, he held senior analytical positions at DIA, ODNI (including the NIC), the Navy staff, CIA, and ONI. His writings on the intersections of government—especially intelligence—and complexity have been published in *Foreign Policy, The Washington Post, Studies in Intelligence, Slate, The National Interest, The Hill, War on the Rocks, Defense One,* and *Parameters,* among other outlets. Mr. Kerbel has degrees from the George Washington University and the London School of Economics, as well as professional certifications from the Naval War College and the Naval Postgraduate School. More recently, he was a postgraduate fellow at the Massachusetts Institute of Technology.

Mr. Schenker is a member of the Bretton Woods Committee and the Texas Business Leadership Council, a non-partisan nonprofit of 100 CEOs in the state of Texas who advise Texas state and federal elected officials.
