The Office of University Programs, housed within the Department of Homeland Security's Science & Technology Directorate (S&T), provides access to the nation's universities through its unique Center of Excellence (COE) program. In this capacity, universities conduct research on homeland security challenges and generate tools, technologies, knowledge products, training, and expertise for the homeland security enterprise.

The National Consortium for the Study of Terrorism and Responses to Terrorism (START) is a DHS COE, comprised of an international network of scholars committed to the scientific study of the causes and human consequences of terrorism. The Office of the Secretary of Defense's Minerva Research Initiative aims to deepen understanding of the social and cultural forces that shape U.S. strategic interests around the world. The Minerva program brings together universities, research institutions, and individual scholars and supports interdisciplinary and cross-institutional projects addressing specific topic areas determined by the Secretary of Defense to support Defense-wide strategic policy and operational planning. A critical second program goal is to connect social science insights and methods to current and future defense leadership to inform tomorrow's key security decisions. (POC: Dr. Erin Fitzgerald)

The Strategic Multilayer Assessment (SMA) program provides planning support to Combatant Commands with complex operational imperatives requiring multi-agency, multi-disciplinary solutions that are not within core Service/Agency competency. The SMA office has developed a proven methodology merging multi-agency expertise and information to address complex operational requirements that call for multi-disciplinary approaches utilizing skill sets not normally present within any one service/agency. The SMA process uses robust multi-agency collaboration leveraging intellectual/analytical rigor to examine factual/empirical evidence with the focus on synthesizing existing knowledge. The end product consists of actionable strategies and recommendations, which can then be used by planners to support COA Development.
